- c) Use the cases above to illustrate the meaning of 'liberal states engaging in illiberal actions' (4 marks)
- d) Explain any TWO issues that illustrate criticisms against the concept of globalization. (5 marks)
- e) Given the events stated in the case study, mention TWO reasons why studying International Relations is necessary (4 marks)
- f) Using the case study critically examine the relevance of the statement that a state "possesses the monopoly over the legitimate use of force or violence" (5 marks)
- g) Explain any mechanism of balance of power being applied by states in the Syrian Conflict (2 marks)

- a) Critically examine the realists assumptions about a state (10 marks)
- b) Using examples, explain the following as used in International Relations:
