QUESTION 1 COMPULSORY: (30 MARKS)

- a. Define the following and provide examples:
- i. Intergovernmental Organizations. (3 marks)
 - ii. Non-governmental Organizations. (3 marks)
 - iii. Multinational Corporations. (3 marks)
- b. The United Nations is prominent in contemporary international relations. Highlight how the UN is used as a platform for the peaceful settlement of disputes in international affairs. Provide relevant examples. (9 marks)
- c. “In an anarchic international environment, states are in constant pursuit of their national interests. This makes states prone to extreme competition amongst each other. International organizations have emerged as a means to pursue collective interests and reduce the chances of war.” Discuss whether or not you agree with this argument. Justify your answer with relevant examples. (12 marks)

QUESTION 2

- a. Identify and explain the functions of the six organs of the United Nations. (12 marks)
- b. Comment on Chapter VI and VII of the United Nations Charter with regard to collective security. (8 marks)

QUESTION 3

- a. International organizations serve as an interactive arena, facilitate functional cooperation, promote comprehensive cooperation, and perform as independent actors. Discuss. (15 marks)
- b. Highlight the main difference in the scope of global and regional organizations. (5 marks)

QUESTION 4

- a. Briefly discuss the difference between the League of Nations and United Nations and the factors that led to the failure of the former and the future prospect of the latter. **(14 marks)**

- b. There was renewed hope that the end of the Cold War signaled a positive change in using the UN to promote international peace and security. Comment. **(6 marks)**

QUESTION 5

- a. One of the ways in which international organizations are formed is through treaties. Discuss the treaty making process. **(12 marks)**

- b. Using a regional international organization as an example, demonstrate the achievements made by the IO and challenges faced in its activities. **(8 marks)**
