#### **QUESTION ONE**

- a) Your sister who has been living in Europe while pursuing her doctoral studies has just returned home for the Christmas holidays. She is aware that you have been studying human rights law this semester and she therefore invites you to a debate on certain African practices such as female genital mutilation, forced marriages, treatment of widows, child marriages etc. She strongly believes that those practices are extremely harmful and amount to violation of human rights. On the other hand, you also hold the view that some of those practices are good because they uphold and preserve the African heritage. Now, you have the big task of demonstrating to your sister that you understand the debate on universalism versus cultural relativism. Discuss. (20 Marks)

#### **QUESTION TWO**

Your friend Miss Rafiki Mzuri runs a human rights organization in Nairobi. So far, she has been receiving several complaints from victims of human rights violations. She therefore intends to start instituting cases in court to avert future violations of human rights. However, she does not know whether instituting court cases is the best approach to address those violations. She therefore visits your offices seeking advice on what types of remedies/ reliefs that the courts give whenever claims of human rights violations are filed. You are therefore required to discuss any five remedies available to human rights law. (20 Marks)

Children are a vulnerable group and therefore they need protection globally. Using appropriate examples (and where applicable case law) discuss the four core principles under the Convention on the Rights of the Child, 1989 as adopted by the Kenyan Children's Act of 2001. (20 Marks)
